APPROPRIATION ORDINANCE NO. 2019-007

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 4 FOR FY 2019 FOR THE CAPITAL OUTLAY-PUBLIC INFRASTRUCTURE-WIDENING OF BATANG-AMBURAYAN FARM-TO-MARKET ROAD INVOLVING AN AMOUNT OF FOUR HUNDRED FIVE THOUSAND PESOS (Php405,000.00) AND NON-OFFICE EXPENDITURES-5% MDRRMF, TWENTY-TWO THOUSAND FIVE HUNDRED PESOS (Php22,500.00), 5% GAD-MAINTENANCE OF ROADS, TWENTY-TWO THOUSAND FIVE HUNDRED PESOS (Php22,500.00), CHARGEABLE AGAINST THE NON-TAX REVENUE-OTHER INCOME-INTEREST INCOME, THIS MUNICIPALITY.

Be it enacted in Regular Session of the Sangguniang Bayan of Santol, La Union, that:

Section 1. The Supplemental Budget No. 4 for FY 2019 of the Municipality of Santol, La Union in the total amount of FOUR HUNDRED FIFTY THOUSAND PESOS (Php450,000.00) is hereby approved.
