APPROPRIATION ORDINANCE NO. 2020-001

AN ORDINANCE APPROVING THE APPROPRIATION OF FUND FROM THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT TRUST FUND AMOUNTING TO FIVE HUNDRED THIRTY THOUSAND AND FIVE HUNDRED PESOS(Php530,500.00) FOR THE PURCHASE OF TENTS, TABLES & CHAIRS AND LED WALL MONITOR AMOUNTING TO ONE HUNDRED THOUSAND FIVE HUNDRED PESOS (Php100,500.00) AND FOUR HUNDRED THIRTY THOUSAND PESOS (Php430,000.00), RESPECTIVELY.

WHEREAS, as per National Disaster Risk Reduction and Management Council (NDRRMC), Department of Budget and Management (DBM) and Department of Interior and Local Government (DILG) Joint Circular No. 2013-1 dated March 25, 2013 states under 6.0. Policies and Procedure on the Utilization of the LDRRMF, to wit:

WHEREAS, to fully implement the same and to substantially comply with the rules and regulations on accounting and auditing of government projects using public funds, the proposed project was identified and prepared in consideration and consultation with the Municipal Disaster Risk Reduction and Management Council and Municipal Development Council;

BE IT ORDAINED, by the Sangguniang Bayan of Santol, La Union that:

SECTION 1. There is an available MDRRMF Trust Fund sufficient to finance the following project:
