APPROPRIATION ORDINANCE NO. 2020-003

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2 FOR FY 2020 COVERING THE PS-HAZARD PAY, SPECIAL RISK ALLOWANCE AND OVERTIME PAY PURSUANT TO ADMINISTRATIVE ORDER 28 AND BUDGET CIRCULAR 2020-2, MOOE-OTHER MOOE (SUPPORT TO PLANNING SERVICES), AND CO-PURCHASE OF ONE (1) UNIT UPRIGHT FREEZER, CHARGEABLE AGAINST THE PS SAVINGS FROM UNFILLED POSITIONS FROM JANUARY-MAY, 2020, THIS MUNICIPALITY.

Be it enacted in Special Session of the Sangguniang Bayan of Santol, La Union, that:

Section 1. The Supplemental Budget No. 2 for FY 2020 of the Municipality of Santol, La Union in the total amount of FIVE HUNDRED THIRTY-THREE THOUSAND ONE HUNDRED TWENTY-FIVE PESOS & 01/100 (Php533,125.01) is hereby approved.
