APPROPRIATION ORDINANCE NO. 2020-004

ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 03 FOR FY 2020 COVERING THE PS-OVERTIME PAY AND PHILHEALTH CONTRIBUTIONS. MOOE-SUPPORT TO MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE, AND CAPITAL OUTLAY-PURCHASE OF ONE (1) UNIT DUPLICATOR MACHINE CHARGEABLE AGAINST THE PS SAVINGS FROM UNFILLED POSITIONS FROM JUNE-JULY, 2020, THIS MUNICIPALITY.

Be it enacted in RegularSession of the Sangguniang Bayan of Santol, La Union, that:

Section 1. The Supplemental Budget No. 3 for FY 2020 of the Municipality of Santol, La Union in the total amount of ONE HUNDRED EIGHTY-THREE THOUSAND THREE HUNDRED NINETY-NINE PESOS & 04/100 (Php183,399.04) is hereby approved.
