AN ORDINANCE STRICTLY IMPOSING MEASURES TO PREVENT THE SPREAD OF CORONA VIRUS DISEASE 2019 (COVID-19) AND OTHER EMERGING INFECTIOUS DISEASES IN THE MUNICIPALITY OF SANTOL, LA UNION AND FOR OTHER PURPOSES, PROVIDING PENALTIES FOR VIOLATION THEREOF.

BE IT ORDAINED by the Sangguniang Bayan of Santol, La Union in session duly assembled that:

SECTION 1. TITLE. This Ordinance shall be known as *“AN ORDINANCE STRICTLY IMPOSING MEASURES TO STEM THE TRANSMISSION OF CORONA VIRUS 2019 (COVID-19) IN THE MUNICIPALITY OF SANTOL, LA UNION.”*

SECTION 2. SCOPE. This Ordinance shall cover all residents and transients in all barangays of Santol, La Union.

SECTION 3. DEFINITION OF TERMS. As used in this Ordinance, the following terms shall mean:

- a. **Emerging Infectious Disease** – an infectious disease that has newly appeared in a population or that has been known for some time but is rapidly increasing in incidence or geographic range;
- b. **Face Mask** – a protective mask or other equipment covering the nose and mouth or nose and eyes, such as indigenous, reusable, reusable, homemade, do-it-yourself masks, face shields, handkerchiefs and the like;
- c. **Holding Area** – a designated place where the violators shall be held for counseling and to correct disobedience;
- d. **Home Quarantine Pass** – a pass issued to one person per household giving access to him/her to leave their residence solely for purposes of buying food, medicines and other basic necessities, and health services;
- e. **Person** – human being regarded as individual, regardless of age and gender; and
- f. **Transient** – a person who is staying or working in a place for only a short time.

SECTION 4. REGULATED ACTS. To prevent the spread of Corona Virus Disease 2019 (COVID-19) in the Municipality of Santol, La Union, the following measures shall be strictly imposed:

- a. A person, whenever allowed to go out of his/her residence shall wear face mask at all times;
- b. All persons in public places shall observe social (physical) distancing by being one meter apart from each other;

- c. The person designated by his/her household to be issued the Home Quarantine Pass (HQP) shall use it on the days as may be prescribed and solely for the purpose it is intended. Any person is prohibited to leave his/her residence without the HQP;
- d. No Senior Citizen and minor individual shall be allowed to roaming/loitering around;
- e. All mass gatherings are deterred. Any person organizing such gathering shall be held accountable;
- f. Mass public transportation is suspended; however, vehicles may be used by a person issued the HQP to access basic necessities or health services;
- g. Consumption of intoxicating liquor or alcoholic beverage in public shall be prohibited. Selling, furnishing, buying, serving, and dispensing thereof shall likewise be prohibited.

SECTION 5. IMPLEMENTING GUIDELINES. The Municipal Inter-Agency Task Force created by the Municipal Mayor through an Executive Order, shall issue the implementing guidelines for this Ordinance.

SECTION 6. PENALTY CLAUSE. Any person who violates any of the provision of this Ordinance shall be penalized as follows:

First Offense	-	Php	1,000.00
Second Offense	-		1,500.00
Third & Succeeding Offenses	-		2,500.00

SECTION 7. SEPARABILITY CLAUSE. If any section or part of this ordinance is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect upon its approval and posting in all barangays and in at least three (3) other conspicuous places in the municipality and shall remain in force and effect until the State of Public Health Emergency and Enhanced Community Quarantine shall be lifted by the President of the Republic of the Philippines.
