WHEREAS, Section 20 of the Local Government Code of 1991 clothed the Sangguniang Bayan the power to reclassify lands within the jurisdiction of the municipality;

WHEREAS, the Implementing Rules and Regulations (IRR) of the LGC provides that cities and municipalities shall continue to prepare their respective comprehensive land use plans, enacted through zoning ordinances, subject to applicable laws, rules and regulations;

WHEREAS, a letter from the Municipal Mayor, Engr. Magno A. Wailan has been received requesting for the reclassification of the parcel of land located at Barangay Paagan, this municipality under Tax Declaration No. 2018-16-0006-00004 to be used as site for the proposed Memorial Park/Public Cemetery and Sanitary Landfill, this municipality.

AN ORDINANCE RECLASSIFYING THE PARCEL OF LAND PURCHASED BY THE MUNICIPAL GOVERNMENT OF SANTOL UNDER TAX DECLARATION NO. 2018-16-0006-00004 LOCATED AT BARANGAY PAAGAN, SANTOL, LA UNION FROM AGRICULTURAL TO SPECIAL USE CLASSIFICATION-MEMORIAL PARK/PUBLIC CEMETERY AND SANITARY LANDFILL OF THE MUNICIPALITY OF SANTOL, LA UNION.

BE IT ORDAINED by the Sangguniang Bayan of Santol, La Union in session duly assembled that:

SECTION 1. The parcel of land under Tax Declaration No. 2018-16-0006-00004 located at Barangay Paagan, this municipality shall be reclassified from Agricultural to Special Use classification- Memorial Park/Public Cemetery and Sanitary Landfill.

SECTION 2. Repealing Clause. All ordinances, rules or regulations in conflict with the provisions of this ordinance are hereby repealed and or modified accordingly.

SECTION 3. Effectivity. This Ordinance shall take effect immediately after posting and publication as provided by law.
