CASTILLO ON THE DISENGAGEMENT AND TERMINATION FOR A CAUSE OF THE SUBPROJECTS KAPIT BISIG LABAN SA KAHIRAPAN COMPREHENSIVE AND INTEGRATED DELIVERY OF SOCIAL SERVICES-NATIONAL COMMUNITY DRIVEN DEVELOPMENT PROGRAM (KALAH-CIDDS-NCDDP), THIS MUNICIPALITY.
