ORTEGA III, TO KINDLY GRANT FINANCIAL ASSISTANCE AMOUNTING TO Php3,117,824.06 INCLUSIVE OF THE Php750,000 CASH PRIZE OF THE MUNICIPALITY FOR GARNERING THE 2ND PLACE ON THE SEARCH FOR CLEANEST, GREENEST AND SAFEST MUNICIPALITY IN THE PROVINCE OF LA UNION-CATEGORY B.


