RESOLUTION APPROVING THE APPROPRIATION OF Php600,000.00 FOR THE REHABILITATION OF LETTAC SUR FARM-TO-MARKET ROAD, NALASIN SECTION, LETTAC SUR, SANTOL, LA UNION CHARGEABLE AGAINST 70% MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (MDRRMF), AS RECOMMENDED BY THE MUNICIPAL DEVELOPMENT COUNCIL, THIS MUNICIPALITY.

WHEREAS, the Municipal Development Council through Resolution No. MDC-EC-2019-07 was endorsed by the Municipal Mayor, Engr. Magno A. Wailan to this Body requesting for the allocation of said fund;
