RESOLUTION APPROVING THE APPROPRIATION OF Php200,000.00 CHARGEABLE AGAINST THE 70% DISASTER RISK REDUCTION AND MANAGEMENT FUND (DRRMF) FOR THE FORMULATION OF EXECUTIVE-LEGISLATIVE AGENDA (ELA) FOR CY 2020-2022, MAINSTREAMING GENDER AND DEVELOPMENT (GAD), DISASTER RISK REDUCTION (DRR)-CLIMATE CHANGE ADAPTATION (CCA), AS RECOMMENDED BY THE MUNICIPAL DEVELOPMENT COUNCIL, THIS MUNICIPALITY.

**WHEREAS,** the Municipal Development Council through Resolution No. MDC-EC-2019-09 was endorsed by the Municipal Mayor, Engr. Magno A. Wailan to this Body requesting for the approval of the same;

**WHEREAS**, there is a need to update the present ELA as this will serve as a tool for development of the present administration for the next three years;

**WHEREAS,** the ELA is formulated with the involvement and collective effort of the municipal officials, heads of offices, barangay officials and civil society organizations;

WHEREAS, JMC No. 2016-01 dated November 8, 2016 provides the updated guidelines on the Harmonization of Local Plan and Performance Monitoring & Coordination in Fiscal Oversight that mandates every LGU to finalize their development plans specially the Executive-Legislative Agenda (ELA);

WHEREAS, Section 16 of the LGC 1991 mandates every local government unit to "...exercise the power expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic

prosperity and social justice, promote full employment, among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.";

**WHEREAS,** DILG Memorandum Circular No. 2015-77 dated July 21, 2015 issued guidelines on mainstreaming climate change adaptation and disaster reduction in local development planning;

**WHEREAS,** pursuant to JMC Nos. 2016-01 and 2013-01 re: Guidelines on the Localization of the Magna Carta for Women; there is a need to mainstream such in the ELA;

WHEREFORE, on motion of SBM Tirso A. Ledda duly seconded by unanimously, be it;
