## **RESOLUTION NO. 2019-048**

RESOLUTION APPROVING AND ADOPTING THE GENDER AND DEVELOPMENT (GAD) PLAN AND BUDGET FOR CY 2020 OF THE MUNICIPALITY OF SANTOL, LA UNION.

WHEREAS, the Department of the Interior and Local Government (DILG), in partnership with the Office of the National Economic and Development Authority (NEDA), Department of Budget and Management (DBM) and the Philippine Commission on Women (PCW), issued JMC 2016- 01 to amend the JMC 2013-01: Guidelines on the Localization of Magna Carta of Women to clarify the process of costing, allocation and attribution of the GAD budget, as well as the duties and functions of the Department of the Interior and Local Government (DILG) as the lead agency in the review, endorsement and monitoring of submission of the GAD Plan and Budget (GPB) and GAD Accomplishment Report (GAD AR) of Local Government Units (LGUs);

WHEREAS, the Philippine Plan for Gender-Responsive Development (PPGD), 1995-2025 which was adopted through Executive Order No. 273, provided specific services that should be implemented for women in relation to the services stipulated in Republic Act 7160 or the Local Government Code of 1991. Specific provisions are Section 16 and 17, mandating LGUs to promote the general welfare and provide basic services and facilities to their constituents, including the discharge of devolved responsibilities pursuant to the Code;

WHEREAS, the said plan and budget embodied the programs and activities and budgetary allocation for its implementation;

**WHEREAS,** the total aggregated amount of GAD budget is embodied, incorporated and included in the 2020 annual budget of the municipality;

**WHEREAS**, the formulation of the GAD Plan and integrating the same in the Annual Investment Program (AIP) would be a great help in responding gender issues of the locality;
