**RESOLUTION APPROVING/ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 2 FOR CY 2019 OF SANTOL, LA UNION, AS RECOMMENDED BY THE MUNICIPAL DEVELOPMENT COUNCIL.**

**WHEREAS**, Article 410 of the Implementing Guidelines of RA 7160 provides that the Local Development Council shall submit to the Local Finance Committee a copy of the Local Development and Annual Investment Plan prepared and approved during the fiscal year in accordance with applicable laws, specifying therein the proposed projects for inclusion in the local government budget;

**WHEREAS**, on September 25, 2018, the Sangguniang Bayan has approved the Annual Investment Plan (AIP) of the municipality for the CY 2019;

**WHEREAS**, received by the municipality is Local Budget Memorandum No. 79 dated June 14, 2019 of the Department of Budget and Management (DBM) prescribing the guidelines on the release and utilization of the shares of local government units, including posting and reporting requirements to enhance transparency and accountability and to inform the LGU of their respective shares;

**WHEREAS**, as per LBM No. 79, the Municipality of Santol has a Municipal Share worth Php73,381,097.00 of Excise Tax on Locally Manufactured Virginia-Type Cigarettes (RA 7171 under FY 2016 collections)

**WHEREAS**, to concur with the requirements/guidelines on the utilization of the RA 7171 Municipal share, the Municipal Development Council (MDC) convened to discuss the possibility of making adjustments to the 2019 AIP;

**WHEREAS**, the Municipal Development Council (MDC) endorsed to the Sangguniang Bayan the Supplemental AIP approved by the said council in their meeting dated July 11, 2019;

**WHEREAS**, upon deliberation, this Body hereby approves the following proposed projects and activity, as recommended by the MDC:
