RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING THE HON. FRANCISCO EMMANUEL "PACOY" R. ORTEGA III, PROVINCIAL GOVERNOR OF LA UNION TO ALLOCATE SEVENTY-ONE MILLION PESOS (Php71,000,000.00) FROM THE VIRGINIA TOBACCO EXCISE TAX (RA 7171 FUND) PROVINCIAL SHARE FOR THE FOLLOWING PROJECTS, AS RECOMMENDED BY THE MUNICIPAL DEVELOPMENT COUNCIL, THIS MUNICIPALITY.

WHEREAS, the Municipal Development Council through Resolution No. MDC-EC-2019-09 was endorsed by the Municipal Mayor, Engr. Magno A. Wailan to this Body requesting for such endorsement:

WHEREAS, the construction of these infrastructure facilities such as farm-to-market roads and bridges would bring economic opportunities to the farmer-residents of the municipality not to mention these are helpful in the conveyance of agricultural produce/products, goods and services within or to and from the production areas;

WHEREAS, the construction of diversion dams when used for irrigation purposes will give the farmers opportunities to engage in multiple cropping in a year which will enhance production and productivity giving every farmer's family to experience and enjoy better and sustained living;

WHEREAS, the Farmers' Multi-Purpose Buildings will serve as a venue for the farmers' general assemblies, meetings, classes on agricultural technologies to adapt or mitigate climate change, and for handicrafts skills training that would be helpful to augment their income;

WHEREAS, much of the desire of the Municipal Government to support the clamor of the farmer-residents for these ambitious projects but our meager fund is already allocated to priority development projects of the municipality; hence, this noble request;
