RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING THE HON. BERNADETTE ROMULO-PUYAT, SECRETARY, DEPARTMENT OF TOURISM, TO KINDLY CAUSE THE CONSTRUCTION AND INSTALLATION OF SANTOL LANDMARK AMOUNTING TO SIXTEEN MILLION FIVE HUNDRED THOUSAND PESOS (Php16,500,000.00) IN THE HIGHLANDS OF SANTOL.

WHEREAS, Santol is a dead end mountainous municipality which is ten (10) kilometer away from the national highway and about 40 kilometers away from San Fernando City, the Capital of La Union;

WHEREAS, Municipal Government continue to seek possible ways and means to increase its limited income so as to give more sufficient development projects and programs bent on improving the lives of its people;

WHEREAS, tourism is becoming significant to the municipality due to the discoveries of beautiful and fascinating waterfalls to which visitors and tourists beginning to flock the municipality;
