### **RESOLUTION NO. 2019-059**

RESOLUTION AUTHORIZING ENGR. MAGNO A. WAILAN, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HOME DEVELOPMENT MUTUAL FUND (PAG-IBIG) AND LAND BANK OF THE PHILIPPINES ON THE IMPLEMENTATION OF "WEACCESS" FOR THE ON-LINE REMITTANCE OF PAG-IBIG REGULAR MEMBERS OF THE MUNICIPAL GOVERNMENT OF SANTOL.

**WHEREAS**, pursuant to PAG-IBIG Fund Circular No. 355 which requires all employers with at least ten (10) employees to remit their premium contributions and loan repayment thru an electronic payment and collection facility accredited by PAG-IBIG Fund; hence this authorization;

WHEREAS, the Municipal Mayor is hereby authorize to execute the following:

- Subscribe to the Land Bank of the Philippines' (LBP's) internet banking facility known as "weAccess";
- b. Designate authorized signatory to enroll and designate authorized user/s in the LANDBANK "weAccess"
- c. Authorize officer to execute/sign all documents necessary to subscribe to LBP's "weAccess"
- d. Designate/authorize personnel to act as "maker" or "authorizer" for the Municipal Government of Santol's access to LBP's "weAccess" banking facility; and
- e. Amend/add/delete enrolled deposit account/s as source and/or destination account/s, access rights to the "weAccess" modules, authorization rules and/or any information on the original and succeeding enrollments.
