RESOLUTION AUTHORIZING ENGR. MAGNO A. WAILAN, MUNICIPAL MAYOR, TO ENTER INTO AND SIGN FOR IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF SANTOL THE MEMORANDUM OF AGREEMENT WITH THE ILOCOS TRAINING REGIONAL MEDICAL CENTER (ITRMC) REPRESENTED BY EDUARDO M. BADUA III, MD, FPSP, MEDICAL CENTER CHIEF II, TO BE THE BLOOD BANK AND LGU-SANTOL AS THE BLOOD POOL FOR THE NATIONAL VOLUNTARY BLOOD PROGRAM OF THE GOVERNMENT.

WHEREAS, received by this Body is a letter of the Municipal Mayor requesting such authorization;

WHEREAS, RA 7719, otherwise known as the National Voluntary Blood Services Act of 1994 was passed and enacted in order to pursue the State's goal of attaining the objectives of the national voluntary blood program of the government;

WHEREAS, it is the declared policy of RA 7719 to mobilize all sectors of the community to participate in mechanisms for voluntary non-profit collection for blood;

WHEREAS, one of the priorities of the Municipality of Santol is health development for its constituents through the provision and delivery of improved health services;

WHEREAS, the MOA will pave the way of providing medical assistance to the populace particularly when necessity for blood transfusion arises during confinements in hospitals by providing them voluntary donors;

WHEREAS, in order to have expeditious, orderly and effective release, delivery and utilization of the needed blood for patients during confinements, the creation of a Blood Collection Unit at the Santol Lying-in Clinic is therefore imperative;

Badua III, MD, FPSP, Medical Center Chief II, to be the Blood Bank and LGU-Santol as the Blood Pool for the National Voluntary Blood Program of the Government.
