**RESOLUTION NO. 2019-062**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN, TO ENTER INTO AND SIGN IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF SANTOL THE MEMORANDUM OF AGREEMENT WITH THE SATRAP POWER CORPORATION FOR THE FEEDSTOCK SUPPLY NEEDED BY THE LATTER FOR THEIR BIOMASS POWER PLANT PROJECT IN BITALAG, BACNOTAN, LA UNION.**

**WHEREAS**, received by this Body is a letter of the Municipal Mayor requesting such authorization;

**WHEREAS**, that the Committee on Environmental Protection and Human Ecology recommended the passage of the this resolution in their Committee Report No. 2019-029;

**WHEREAS**, the Municipal Government of Santol shall, in accordance with the Ecological Solid Waste Management Act, have the primary responsibility in the collection of MSW in its jurisdiction commencing with Source Separation (the sorting of solid waste into some or all of its component parts at the point of generation) up to Storage (the interim containment of solid waste after generation and prior to collection for ultimate recovery or disposal);

**WHEREAS**, SATRAP shall accord financial benefits to the MGS in accordance with Energy Regulations No. 1-94 in the amount of one centavo per kilowatt hour (Php0-01/kWh) in accordance with Section 66 of the Electric Power Industry Reform Act (EPIRA), as implemented under 29 of the EPIRA Implementing Rules and Regulations;

**WHEREAS**, SATRAP shall, by its Project and no cost to MGS:

1. Enable MGS to be compliant with the Ecological Solid Waste Management Act in the management of its MSW; and

- 2. Enable MGS to perform their functions on climate change adaptations as mandated by the Climate Change Act.

**WHEREFORE**, on motion of William O. Agtarap duly seconded unanimously, be it;

**RESOLVED AS IT IS HEREBY RESOLVED**, to authorize Engr. Magno A. Wailan, Municipal Mayor, to enter into and sign in behalf of the local government unit of Santol the Memorandum of Agreement with the SATRAP Power Corporation for the Feedstock Supply needed by the latter for their Biomass Power Plant Project in Bitalag, Bacnotan, La Union.
