RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE COMMUNITY BASED MONITORING SYSTEM (CBMS) NETWORK TEAM, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT THROUGH THE BUREAU OF LOCAL GOVERNMENT DEVELOPMENT (BLGD) AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE I (DILG ROI) ON THE CONDUCT OF COMMUNITY BASED MONITORING SYSTEM (CBMS), AND FURTHER APPROVING THE NEEDED FUND FOR THE PURPOSE AMOUNTING TO THREE HUNDRED NINETY-FOUR THOUSAND (Php394,000.00), CHARGEABLE AGAINST THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT FUND (MDRRMF-70%), THIS MUNICIPALITY.

WHEREAS, the institutionalization of the CBMS would serve as an effective planning and monitoring tool of Santol and its eleven (11) barangays particularly on poverty diagnosis and implementation of Millennium Development Goal, this municipality;

WHEREAS, the Municipal Planning and Development Office acts as the coordinating body and the center of operations of all committees, bodies, etc. that form the development council and the operation of the council itself either directly or through its executive committee led by the Municipal Mayor;
