RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN TO ENTER INTO A DEED OF USUFRUCT WITH THE SACRECO (PREVIOUSLY SANTOL MULTI-PURPOSE AGRICULTURAL COOPERATIVE), ALLOWING THE SAME TO USE ONE (1) STALL AT THE FARMERS' TRADING CENTER AS THEIR OFFICE FREE OF LEASE.

WHEREAS, Santol Multi-Purpose Agricultural Cooperative (now SACRECO) was granted by the Department of Agriculture of a fund for the construction of their building but they do not have a lot for the purpose;


WHEREAS, through a usufruct agreement between the Municipal Government under the administration of the then Municipal Mayor Floresto C. Sayangda and the Santol Multi-Purpose Agricultural Cooperative, the latter was given a perpetual right to use the lot owned by the Municipal Government for the construction of the Cooperative's building;

WHEREAS, for purposes of development, the Cooperative's Building needed to be demolished to pave way for the construction of the 3-storey Farmers' Trading Center, however, the Cooperative was assured of a space in the FTC and was given the privilege the right to use for free one stall therein;

WHEREAS, the SACRECO shall only use the stall and if in the future desires to transfer to wider and more convenient place, said stall will be reverted to the Municipal Government of Santol:




RESOLVED FURTHER, to forward copies of this resolution to Engr. Magno A. Wailan, for his information and appropriate action.
