WHEREAS, the Department of Social Welfare and Development (DSWD) is the government agency that primarily responsible in delivering coordinated social protection services aimed at eradicating poverty.

WHEREAS, DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality life;
