HERMAN JUMILLA, MINDANAO AFFAIRS SUPERVISION OF THE LOCAL GOVERNMENT AND REGIONAL COORDINATION BUREAU AND DBM REGIONAL OFFICES IN LUZON AND VISAYAS, TO KINDLY CAUSE THE CONSTRUCTION AND OPENING OF KILLO SANITARY LANDFILL ROAD AMOUNTING TO TEN MILLION PESOS (Php10,000,000.00).**

**WHEREAS**, there is a need to relocate the existing sanitary landfill located in between the Municipal Cemetery and a private owned resort;

**WHEREAS**, one of the priority programs of the Municipal Government is the proper disposal of wastes, hence continue to adopt a systematic and comprehensive rules and regulations on solid waste management for the protection of public health and the environment;

**WHEREAS**, the Municipal Government is committed to transfer and establish its own Sanitary Landfill to a site the latter has previously acquired at Barangay Paagan, this municipality and its Environmental Compliance Certificate was already approved by the DENR;

**WHEREAS**, there is a need to open and construct the road going to the proposed site of the Sanitary Landfill for purposes of accessibility not to mention said site is located very distant from the residential area mainly to protect the populace from possible contamination of wastes;

**WHEREAS**, this August Body brings the attached scope of work/activity for the mentioned project to the attention and consideration of the Acting Secretary, Department of Budget and Management (DBM) thru Hon. Herman Jumilla, Mindanao Affairs Supervision of the Local Government and Regional Coordination Bureau and DBM Regional Offices in Luzon and Visayas hoping and praying for its realization;
