HERMAN JUMILLA, MINDANAO AFFAIRS SUPERVISION OF THE LOCAL GOVERNMENT AND REGIONAL COORDINATION BUREAU AND DBM REGIONAL OFFICES IN LUZON AND VISAYAS, TO KINDLY CAUSE THE SUPPLY, INSTALLATION AND COMMISSIONING OF STAND ALONE SOLAR POWERED WATER SYSTEM WITH WATER STORAGE TANK AMOUNTING TO NINE MILLION NINE HUNDRED THOUSAND PESOS (Php9,900,000.00) FOR BARANGAY PUGUIL, SANTOL, LA UNION.

**WHEREAS**, the health of the people is of paramount importance, hence the Municipality of Santol is instituting necessary measures and actions to protect its people and promote safe and potable water supply bringing it to every household in all the barangays of the municipality;

WHEREAS, there are reported cases of morbidity in the municipality associated with water-borne diseases to which most of the affected ones are the poor households that merely relies in deep wells as their source of water supply;

**WHEREAS**, after series of conduct of feasibility study and ocular inspection and with the help of the residents, the technical personnel of the Municipal Government have identified the potential location for the construction of the facility;

**WHEREAS**, this August Body brings the attached scope of work/activity for the mentioned project to the attention and consideration of the Acting Secretary, Department of Budget and Management (DBM) thru Hon. Herman Jumilla, Mindanao Affairs Supervision of the Local Government and Regional Coordination Bureau and DBM Regional Offices in Luzon and Visayas hoping and praying for its realization;
