RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN REPRESENTING THE LGU-SANTOL, LA UNION, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE (DA), RFO I, REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, LUCRECIO R. ALVIAR, CESO III, AND THE AGRICULTURE AND FISHERY COUNCIL (AFC), REPRESENTED BY MR. VINCENT A. ADORNA, CHAIRMAN OF THE REGIONAL AGRICULTURE AND FISHERY COUNCIL ON THE PROPOSED REHABILITATION OF SITIO DAYA DIVERSION DAM, MANGAAN, SANTOL, LA UNION UNDER THE SMALL SCALE IRRIGATION PROJECTS (SSIPs), AMOUNTING TO FOUR MILLION FOUR HUNDRED THOUSAND PESOS (Php4,400,000.00).

WHEREAS, the Municipal Mayor, Engr. Magno A. Wailan has endorsed to the Sangguniang Bayan, for review and consideration, a copy of the proposed Memorandum of Agreement (MOA) Re: Rehabilitation of Sitio Daya Diversion Dam, Mangaan, Santol, La Union under the Small Scale Irrigation Projects (SSIPs), amounting to Four million four hundred thousand pesos (Php4,400,000.00);

WHEREAS, Santol is an agricultural municipality, wherein most of the people mainly engaged in farming as their source of livelihood/income;

WHEREAS, bigger part of the farmland in this area depends solely on rain, forcing the farmers to plant only once a year, thus, causing low farm production and productivity and correspondingly resulted to lower income;

WHEREAS, if this diversion dam be rehabilitated, this would bring hope for the farmers to grow more pastures and crops as this facilitates the water for the irrigation thereat;

WHEREAS, water impounding project, mini-dam and irrigation projects would be of great help to uplift the economic life among the farmers in the municipality;
