RESOLUTION APPROVING THE APPROPRIATION OF SIXTY-NINE THOUSAND SIX HUNDRED PESOS (Php69,600.00) CHARGEABLE AGAINST THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT FUND FOR THE PURCHASE OF INSECTICIDE FOR THE FOGGING OPERATION OF THE MUNICIPAL HEALTH OFFICE-SANITARY DEPARTMENT, THIS MUNICIPALITY.

WHEREAS, there is an increasing number of reported cases of dengue fever in the municipality;
