TUBALLA, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGIONAL OFFICE I, TO GRANT THE MUNICIPAL GOVERNMENT OF SANTOL, LA UNION REPRESENTED BY THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN THE CUTTING OF THE TWO (2) ACACIA TREES LOCATED INFRONT OF THE MUNICIPAL BUILDING, THIS MUNICIPALITY.**

**WHEREAS**, the Municipal Government has allocated funds for the improvement and beautification of the façade of the Municipal Hall and said trees is an obstruction to the project;

**WHEREAS**, said trees lean towards the Municipal Hall in the same way posing danger to the workers of the LGU and damages to the hall especially during rainy season when strong typhoons usually occur;

**WHEREAS**, the roots of the acacia tree is becoming bigger as they get older causing cracks and damages to the pavement in front of the Municipal Hall and also to the provincial road. Hence, in order to prevent the occurrence of bigger damages said trees need to be cut;

**THE SANGGUNIANG BAYAN OF SANTOL, LA UNION IN SESSION DULY ASSEMBLED:**


