RESOLUTION NO. 2019-126

WHEREAS, on November 22, 2019, the Honorable Mayor, Engr. Magno A. Wailan received the letter from the Philippine Drug Enforcement Agency (PDEA), Regional Office No. 1, La Union Provincial Office, informing that the municipality has already successfully completed all the requirements of Barangay clearing set forth pursuant to Dangerous Drug Board Regulation No. 3, Series of 2017 and that the Oversight Committee on Barangay Clearing Program composed of the Department of the Interior and Local Government (DILG), Philippine Drug Enforcement Agency (PDEA), Department of Health (DOH), Philippine National Police (PNP) and the Provincial Government of La Union (PGLU) has given the signal to arrange a schedule for the formal declaration of the Municipality of Santol as Drug-Cleared Municipality;

WHEREAS, the good news is a welcome development as it means that the Municipality of Santol is now rightfully a Drug-Free Municipality;

WHEREAS, the declaration has been long awaited by the Municipal Government not to mention has really gave its effort and resources only to rehabilitate the drug offenders in the municipality with its main objective of reforming them into self-sufficient and law-abiding members of the society;

WHEREAS, the task of keeping Santol free from drugs was not a responsibility of the Municipal Government alone but a concerted effort of different sectors that included the Punong Barangays and their officials, the Philippine National Police (PNP), Non-Government Organizations (NGOs) and the townspeople of Santol in general;

THE SANGGUNIANG BAYAN OF SANTOL, LA UNION IN SESSION DULY ASSEMBLED:






