WHEREAS, the Municipal Government has established a Municipal Health and Diagnostic Center to cater primarily for the immediate health services needs of every Santolian;

WHEREAS, the Municipal Government is developing the MHDC as a hub for the delivery of quality medical and maternal care for the people of Santol and nearby municipalities and provinces like Ilocos Sur and Benguet;

WHEREAS, the MHDC is the nearest source of medical attention to the residents of Santol, the nearest emergency hospital located in the municipality of Balaoan is more or less 15 kilometers away from the town proper and some 50 kilometers from the farthest barangay, thus making it difficult to save life during emergency situations;

WHEREAS, the MHDC has no sufficient rooms for confinement purposes especially to those sick or injured individual and mothers giving birth needing care and treatment, hence the construction of the infirmary building will pave way to the accommodation of patients referred for confinement;

WHEREAS, if this request be realized, the Municipal Government pledges its counterpart of the availability of lot for the proposed project;

WHEREAS, this Body appeals that if this humble request be approved will be downloaded to the Municipal Government for implementation of the same by administration to ensure closer monitoring of the project;
