RESOLUTION ADOPTING THE REVISED CITIZEN'S CHARTER ENTITLED PAGSADAGAN ITAN CITIZEN'S CHARTER OF THE MUNICIPAL GOVERNMENT OF SANTOL, LA UNION.

WHEREAS, submitted to this Body is a letter of Mayor Magno A. Wailan dated December 2, 2019, requesting the Sangguniang Bayan to adopt the Citizen's Charter of the Municipal Government of Santol;

WHEREAS, pursuant to R.A. No. 11032 or the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018, "amending R.A. No. 9485 or the Anti-Red Tape Act of 2007, the Municipal Government of Santol has revised its existing Citizen's Charter in response to the urgent order of the President Rodrigo Roa Duterte in his last 2019 State of the National Address where he reiterated his "directive to the government and instrumentalities, including the LGUs and the government corporations: simplify", the Anti-Red Tape Authority is fast tracking projects and programs to streamline and improve government service delivery;

WHEREAS, the Citizens Charter is the official document that will communicate, in simple terms, the service standards or pledge of an agency on the government services being provided to the citizens; hence, this LGU is mandated to revised its Citizen's Charter that shall contain all of the government services that government offices offer to ensure the efficient, transparent, accountable delivery of government service;

WHEREAS, said Citizen's Charter will serve as a reference manual for the community to be appraised of the duties and responsibilities of public officials at the processes involved in availing the services due to them;
