RESOLUTION NO. 2019-145

RESOLUTION APPROVING AND ADOPTING THE MUNICIPAL REVENUE GENERATION PLAN FOR CY 2019-2024 OF THE MUNICIPALITY OF SANTOL, LA UNION, AS RECOMMENDED BY THE MUNICIPAL DEVELOPMENT COUNCIL.

WHEREAS, endorsed to this Body by the Municipal Mayor is Resolution No. MDC-EC-2019-05 requesting for the adoption of the Municipal Revenue Generation Plan for CY 2019-2024, this municipality;

WHEREAS, the state recognized that there is a need to provide sufficient powers, authority, responsibilities and resources to the Local Government Units (LGUs) to make them self-reliant communities. Thus, among the authorities and powers granted to LGUs under R.A. 7160, otherwise known as the Local Government Code of 1991, is the power to generate resources to supplement national government's assistance through Internal Revenue Allotment (IRA) and grants;

WHEREAS, under Section 18 of the LGC, LGUs are authorized through its Sanggunian to levy taxes, fees and charges and create other sources of revenues for its exclusive use and disposition;

WHEREAS, there is a need to generate a revenue strategy like Revenue Generation Plan that focuses on increasing the LGU's income and maximizing both short term and long term revenue collections potential;

WHEREAS, the formulated MRGP encompasses alignment of the strategy, structure, people and process of the LGU bent on improving the revenue collections of the municipality;

WHEREFORE, on motion of SBM Roxanne M. Dangle duly seconded unanimously, be it;
