WHEREAS, the Municipal Officials and Heads of Offices of the Municipality of Santol has witnessed the progressive and developed Manila that always resounding through print and social media;















WHEREAS, the Municipal Government of Santol would want to reciprocate the best practices of the City Government of Manila but we could not sustain due to our limited resources;
