RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN, TO ENTER INTO, AND SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTOL THE MEMORANDUM OF PARTNERSHIP AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-REGION I, REPRESENTED BY REGIONAL EXECUTIVE DIRECTOR, ATTY. CRIZALDY M. BARCELO THRU FORESTER MAXIMO F. SORIANO, JR, PEN OFFICER, ON THE IMPLEMENTATION OF PUBLIC LAND TITLING PROJECT, THIS MUNICIPALITY.

WHEREAS, pursuant to Executive Order No. 192, granting DENR the power to promulgate rules and regulations necessary to facilitate public land titling, and in order to provide more efficient land titling services to the public in furtherance of Commonwealth Act No. 141, otherwise known as the "Public Land Act", Republic Act No. 10023 "Residential Free Patent Law" and Republic Act No. 7160 or the Local Government Code of 1991, authorizing LGUs to facilitate titling of public lands;


WHEREAS, the DENR-PENRO, San Fernando City, Land Management Services recognizes the important role of the Local Government as the partner of the project in the conduct of activities and delivery of services to its constituents in the Municipality of Santol;
