RESOLUTION AUTHORIZING THE TEMPORARY CLOSURE OF THE SANTOL-BALAOAN PROVINCIAL ROAD PARTICULARLY PNP SANTOL STATION TO CCLT SECTION FROM FEBRUARY 7, 2020 TO MARCH 12, 2020 TO ACCOMMODATE THE "PISTAHAN VILLAGE" ON THE OCCASION OF THE ITAN FESTIVAL 2020.

WHEREAS, endorsed to this Sanggunian is the letter from the Municipal Mayor, Engr. Magno A. Wailan requesting the same;

WHEREAS, the Pistahan Village was designed as a venue where food handlers sell cooked or readily edible foods or the usually called "night market" where people go and eat;

WHEREAS, the conduct of "Pistahan Village" activity would give the business sector particularly the food handlers an opportunity to earn a living;

WHEREAS, under the Local Government Code of 199, a road, street or thoroughfare may not be temporarily closed upon authority of the local Sanggunian concerned;

WHEREFORE, on motion of SBM Tirso A. Ledda unanimously seconded, be it;
