RESOLUTION NO. 2020-017

RESOLUTION DECLARING THE FOLLOWING PRECAUTIONARY/PREVENTIVE MEASURES ON THE THREAT OF CORONA VIRUS DISEASE-19 (COVID-19) AND IN PURSUANCE TO PRESIDENTIAL PROCLAMATION NO. 922, DECLARING A STATE OF PUBLIC HEALTH EMERGENCY THROUGHOUT THE PHILIPPINES AND OTHER RELATED ISSUANCES, LAWS AND PROCLAMATIONS IN THE MUNICIPALITY OF SANTOL, LA UNION.

WHEREAS, in order to contain the spread of COVID-19, the following precautionary/preventive measures are hereby imposed in the Municipality of Santol:

- a) Classes at all levels in all schools within the jurisdiction of Santol will be suspended from March 16, 2020 to April 12, 2020;
- b) All tourist destinations/sites shall be temporarily closed to tourists as well as all Eco-Tourism and other related activities will also be suspended;
- c) All persons with domestic and overseas travel history (from places with COVID-19 confirmed cases) coming in Santol shall submit themselves for home quarantine and follow the Department of Health mandatory health protocols. The Barangay Health Emergency Response Teams and the Municipal Health Office shall be responsible in the monitoring of possible COVID-19 patients. In case of resistance or non-compliance of both parties, the Municipal Government of Santol will coordinate with police authority for assistance, as this concerns public health and safety;
- d) All large events aimed at stemming the spread of COVID-19 shall be cancelled or postponed;
- e) All public transport vehicle operators/drivers (tricycles and jeepneys) traversing the municipality shall conduct regular sanitation/disinfection of their respective vehicles;
- f) No minors (17 years old and below) are allowed to roam and loiter in public places. Parents are advised to monitor and guide their children;
- g) The ITAN Festival/Annual Town Fiesta of Santol is postponed indefinitely as recommended by the Municipal Inter-Agency Task Force on COVID-19 as this is a huge crowd event which will possibly stem the spread of the same;

- h) The Municipal Government of Santol will adopt the Alternative Work Scheme prescribed by the Civil Service Commission. The new work schedule will be from Monday-Thursday, 7:30 a.m. to 6:30 p.m. and the new work scheme, however, will not cover offices that provide frontline services particularly the Municipal Health Office/Santol Lying-in Clinic, MDRRMO, Municipal Agricultural Office and Municipal Social Welfare and Development Office, which will function 24/7;
- i) Biometrics Attendance Tracking System shall be suspended as similar precautionary measure. In the meantime, employees of the Municipal Government of Santol will have to write their names in the logbooks provided by the Human Resource and Management Officer; and
- j) All are encouraged to practice DOH's recommended health protocols such as proper hand washing, cough etiquette, personal hygiene, vitamin supplement, healthy diet and increase in warm water intake.

WHEREAS, the Municipal Government of Santol is committed to protect its employees and the whole constituency in general amid COVID-19;

WHEREAS, the created Municipal Inter-Agency Task Force for COVID-19 shall meet consistently and implement above-mentioned measures and other related measures against the possible spread of the COVID-19 in the municipality;

WHEREAS, the Municipal Government of Santol reiterates President Duterte's statement asking everyone to have patience, stay calm and help each other in this time of crisis, obeying health authorities and implementers and not downplaying the COVID-19 are the best things to do as this concerns public health and safety;


WHEREFORE, on motion of SBM Editha R. Millares duly seconded unanimously, be it;


THE SANGGUNIANG BAYAN OF SANTOL, LA UNION IN SESSION DULY ASSEMBLED:
