## **RESOLUTION NO. 2020-018**

RESOLUTION DECLARING THE MUNICIPALITY OF SANTOL, LA UNION UNDER STATE OF CALAMITY PURSUANT TO THE DECLARATION OF PRESIDENT RODRIGO R. DUTERTE PLACING ENTIRE LUZON UNDER ENHANCED COMMUNITY QUARANTINE AMID CORONA VIRUS DISEASE-19.

**WHEREAS**, Section 15, Article II of the Constitution of the Philippines provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that local government units shall promote health and safety of their inhabitants;

**WHEREAS,** Section 1 of Presidential Proclamation No. 922 declared a State of Public Health Emergency throughout the country due to COVID-19;

**WHEREAS,** Section 2 thereof, enjoined all local government units to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat;

WHEREAS, President Rodrigo R. Duterte has declared entire Luzon under Enhanced Community Quarantine giving directives to Local Government Units to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain and prevent the spread of COVID-19, mitigate its effects and impact to the community and prevent serious disruption on the function of the government and the community;

**WHEREAS**, in view of the threats that the municipality is facing, this Body hereby declares the Municipality of Santol under State of Calamity to provide assistance necessary to curtail the spread of the COVID-19;



WHEREFORE, on motion of SBM Jojo O. Ominga duly seconded unanimously, be it;

THE SANGGUNIANG BAYAN OF SANTOL, LA UNION IN SESSION DULY ASSEMBLED:

**RESOLVED AS IT IS HEREBY RESOLVED**, to declare the Municipality of Santol, La Union under State of Calamity pursuant to the declaration of **PRESIDENT RODRIGO R. DUTERTE** placing entire Luzon under Enhanced Community Quarantine amid Corona Virus Disease-19.
