**RESOLUTION NO. 2020-020**

**RESOLUTION AUTHORIZING THE PURCHASE OF BASIC SUPPLIES AND COMMODITIES AS PREVENTION AND MITIGATION AMID COVID-19 CHARGEABLE AGAINST THE MDRRM FUND SAVINGS FOR THE YEAR 2015 UNDER THE SPECIAL TRUST FUND AMOUNTING TO PHP3,000,000.00, THIS MUNICIPALITY.**

**WHEREAS**, President Rodrigo R. Duterte has declared entire Luzon under Enhanced Community Quarantine giving directives to Local Government Units to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain and prevent the spread of COVID-19, mitigate its effects and impact to the community and prevent serious disruption on the function of the government and the community;

**WHEREAS**, in view of the threats that the municipality is facing, this Body has declared the Municipality of Santol under State of Calamity to provide assistance necessary to curtail the spread of the COVID-19;

**WHEREAS**, this Body has received a Joint Resolution of the MDC-EC and MDRRM No. 2020-01 requesting the SB for the approval of appropriation of Php3,000,000.00 chargeable against the MDRRM Fund savings for the year 2015 to 2019 under the Special Trust Fund;

**WHEREAS**, there is an available fund as per certification issued by the Municipal Accountant, Municipal Budget Officer and the OIC-Municipal Treasurer from the MDRRM Fund savings for the year 2015 to 2019 under the Special Trust Fund amounting to **Three million pesos (Php3,000,000.00)**. Said fund will be reverted back to the General Fund and made available for other social services;

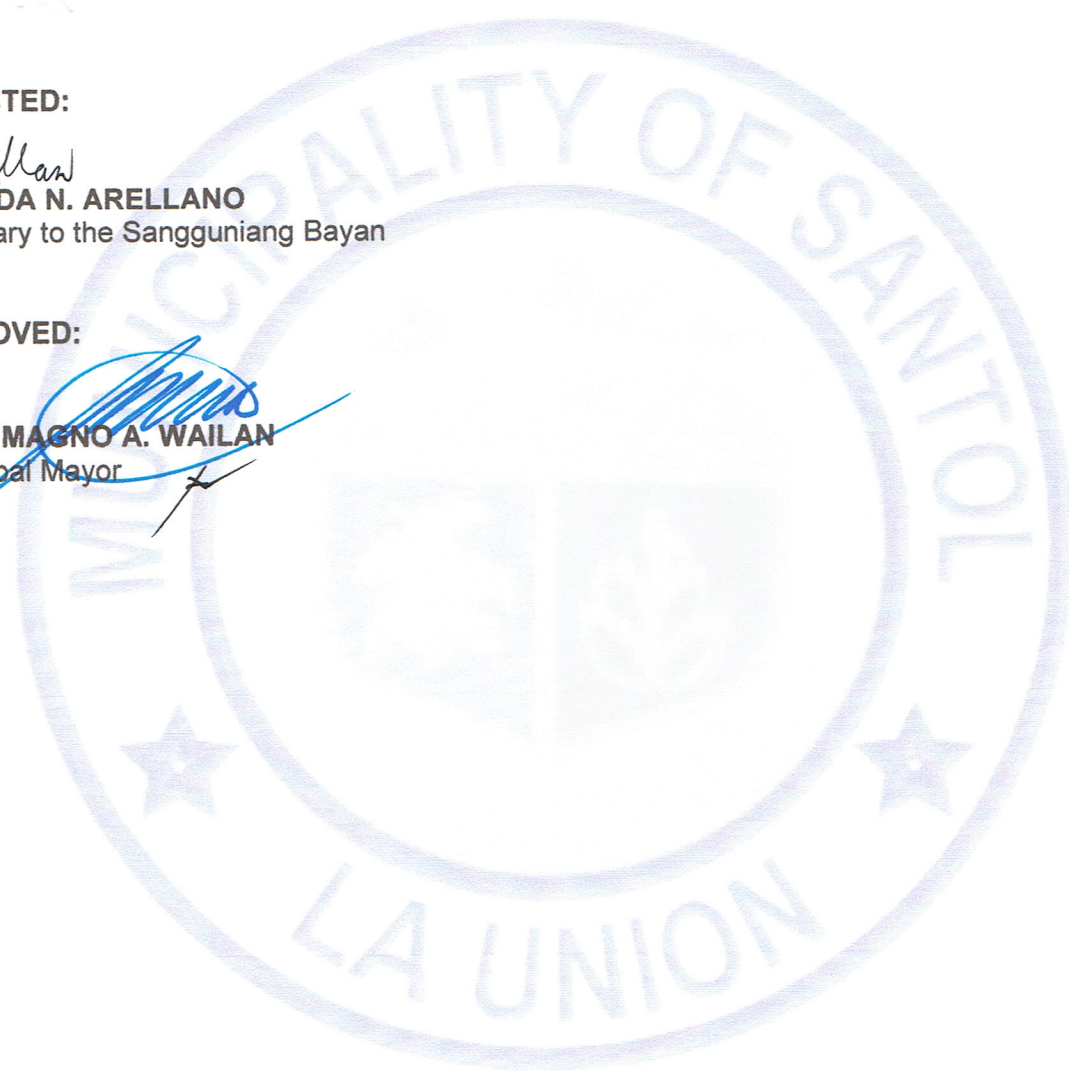
