RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD AUTHORITY REGARDING THE SALE/PURCHASE OF RICE ON CREDIT IN TIMES OF CALAMITIES/EMERGENCIES, THIS MUNICIPALITY.

WHEREAS, presented before this body for consideration is a letter from the Municipal Mayor dated March 17, 2020 re: passed of an appropriate resolution authorizing him to enter into a MOA with the National Food Authority regarding the sale/purchase of rice on credit in times of calamities/emergencies;

WHEREAS, one of the current programs of the NFA is to assist Local Government Units in times of calamities/emergencies thru the sale of rice to be used for relief or stocking operations;
