**WHEREAS**, President Rodrigo Roa Duterte has issued Presidential Proclamation No. 922, s. 2020 declared a State of Public Health Emergency throughout the country and Proclamation No. 929, s. 2020, placing the entire Philippines under the State of Calamity, respectively due to COVID-19;

**WHEREAS**, the Enhanced Community Quarantine has resulted to panic buying of basic goods and necessities and due to the imposition of the same, food supplies are no longer enough to supply the needs of the people;

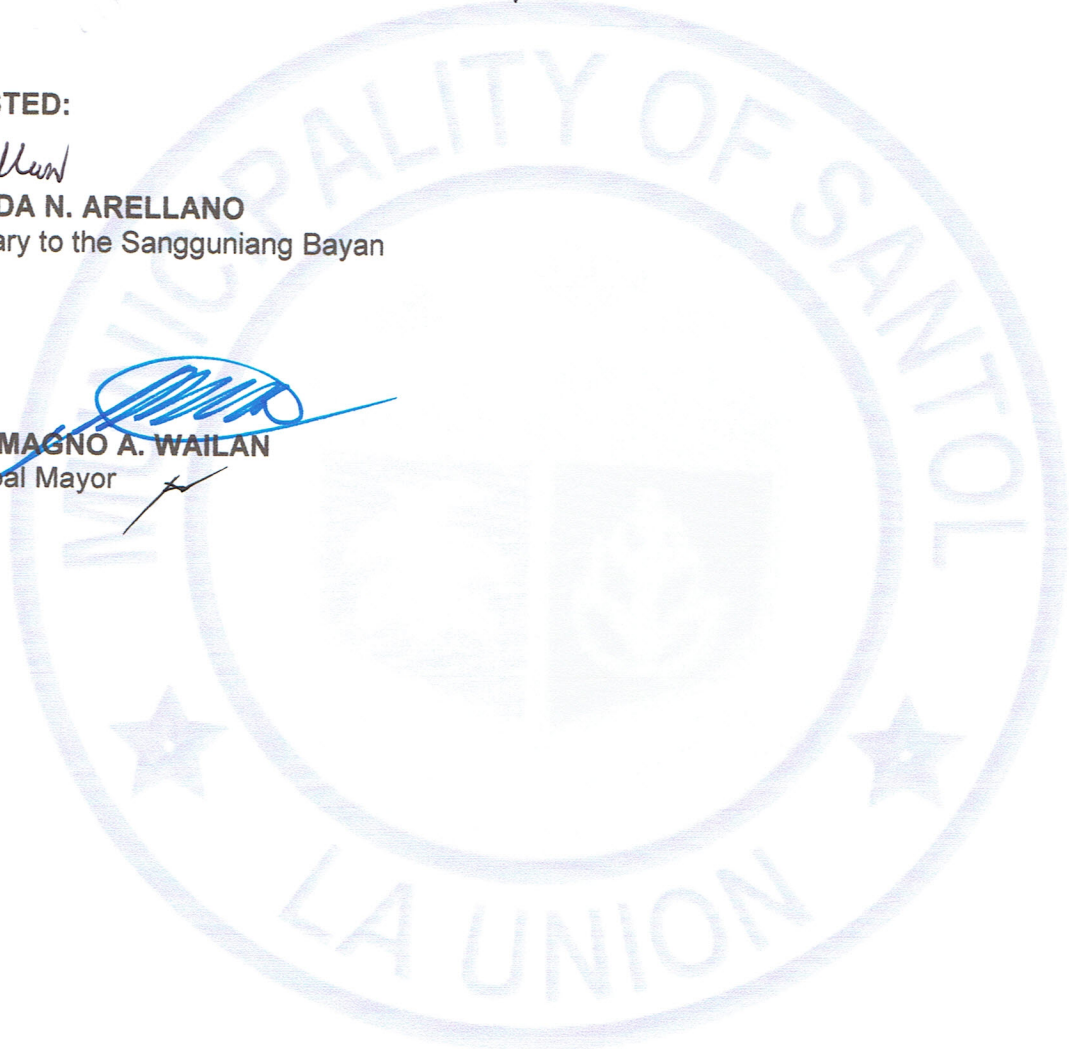
