RESOLUTION NO. 2020-025

RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING HON. LUIS "CHAVIT" SINGSON, PRESIDENT, LEAGUE OF MUNICIPALITIES OF THE PHILIPPINES, TO KINDLY DONATE FOOD ASSISTANCE FOR THE ENTIRE CONSTITUENCY OF SANTOL, LA UNION DUE TO THE ENHANCED COMMUNITY QUARANTINE OVER THE ENTIRE LUZON AMID THE WORSENING COVID-19.

WHEREAS, President Rodrigo Roa Duterte has issued Presidential Proclamation No. 922, s. 2020 declared a State of Public Health Emergency throughout the country and Proclamation No. 929, s. 2020, placing the entire Philippines under the State of Calamity, respectively due to COVID-19;
