RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING HON. DELFIN N. LORENZANA, SECRETARY AND CHAIRPERSON, DEPARMENT OF NATIONAL DEFENSE AND NATIONAL DISASTER RISK REDUCTION MANAGEMENENT COUNCIL (NDRRMC), RESPECTIVELY THRU USEC RICARDO B. HALAD, TO KINDLY DONATE FOOD ASSISTANCE FOR THE ENTIRE CONSTITUENCY OF SANTOL, LA UNION DUE TO THE ENHANCED COMMUNITY QUARANTINE OVER THE ENTIRE LUZON AMID THE WORSENING COVID-19.

WHEREAS, President Rodrigo Roa Duterte has issued Presidential Proclamation No. 922, s. 2020 declared a State of Public Health Emergency throughout the country and Proclamation No. 929, s. 2020, placing the entire Philippines under the State of Calamity, respectively due to COVID-19;

WHEREAS, the Enhanced Community Quarantine has resulted to panic buying of basic goods and necessities and due to the imposition of the same, food supplies are no longer enough to supply the needs of the people;

WHEREAS, we find it difficult to go out of the municipality not to mention some of the nearby municipalities to which we usually buy our basic needs imposed lockdown to also protect their people and more so we need to adhere to the orders concerning our safety and welfare too;

WHEREAS, Santol is a 4th income class municipality merely dependent to its IRA and the meager MDRRM Fund could not fully support the entire constituency in this heightened situation, hence we really need the support and assistance of the national government, entities and individuals who are willing to extend a helping hand;

WHEREAS, the emergency resulting from the spread of the virus is having a rapid and negative effect on the farmers who are timely harvesting their fruits and vegetable produce and

it is a burden on their side to dispose the same due to travel restrictions. Because of this scenario, bankruptcy on the part of the farmers is expected resulting to struggle on their other basic needs;
