**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), DEPARTMENT OF TRADE AND INDUSTRY (DTI), DEPARTMENT OF AGRICULTURE (DA), DEPARTMENT OF FINANCE (DOF), DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), AND DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), FOR THE IMPLEMENTATION OF THE SOCIAL AMELIORATION PROGRAMS (SAPS) PURSUANT TO REPUBLIC ACT (RA) NO. 11469, OTHERWISE KNOWN AS THE "BAYANIHAN TO HEAL AS ONE ACT OF 2020" AND PRESCRIBED UNDER DSWD-DOLE-DTI-DA-DOF-DBM-DILG JOINT MEMORANDUM CIRCULAR NO. 1, SERIES OF 2020 OR THE SPECIAL GUIDELINES ON THE PROVISION OF SOCIAL AMELIORATION MEASURES.**

WHEREAS, the Municipal Government of Santol pledges its commitment to be the partner of the National Government in the expeditious delivery of assistance under the SAP;


