RESOLUTION AUTHORIZING ENGR. MAGNO A. WAILAN, MUNICIPAL MAYOR AND MRS. LOVELLA O. GAMUEDA, OIC-MUNICIPAL TREASURER OF THE LOCAL GOVERNMENT OF SANTOL, LA UNION TO OPEN A TRUST ACCOUNT FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGMC) IN ITS DEPOSITORY BANK, LAND BANK OF THE PHILIPPINES, SAN FERNANDO CITY, LA UNION BRANCH.

WHEREAS, as stated in Section 309, (b) of the Local Government Code of 1991, there shall be maintained in every provincial, city, municipal treasury xxx trust funds which shall consist of private and public monies which have officially come into the possession of the local government unit or of a local government official as trustee, agent or administrator, or which have been received as a guaranty for the fulfillment of some obligation. A trust fund shall only be used for the specific purpose for which it was created for or for which it came into the possession of the local government unit;

WHEREAS, thru Local Budget Circular No. 125 issued by the Department of Budget and Management entitled, "Guidelines on the release and utilization of the Bayanihan Grant to Cities and Municipalities (BGCM), to which the grant shall be equivalent to the one-month FY 2020 Internal Revenue Allotment share of the municipality amounting to Php6,445,231.00;

WHEREAS, the Local Chief Executive has requested this august Body to authorize the opening of trust fund to set aside for the aforementioned grant;

WHEREFORE, on motion of SBM Jojo O. Ominga duly seconded unanimously, be it;
