RESOLUTION APPROVING THE REALIGNMENT OF FUNDS UNDER THE MUNICIPAL DEVELOPMENT FUND FOR CY 2020 FROM THE FOLLOWING PROJECTS: A) CONSTRUCTION OF SAGINGSING MULTI-PURPOSE BLDG. - ₱1,000,000.00, B) IMPROVEMENT OF VARIOUS FOOT PATHS IN BARANGAY RAMOT - ₱500,000.00 FOR THE COMPLETION OF PAAGAN WATER SYSTEM AMOUNTING TO ₱1,500,000.00, THIS MUNICIPALITY.

WHEREAS, submitted before this Body is a letter of the Municipal Mayor, Engr. Magno A. Wailan dated May 27, 2020 requesting said realignment;

WHEREAS, the ongoing Water System Project at Barangay Paagan funded under the Department of Interior and Local Government-Assistant to Municipalities (DILG-AM) is fall short of fund as there were significant parts needed to be constructed and installed to make it functional; hence, this realignment;

WHEREAS, upon the recommendation of the Local Finance Committee and the Municipal Engineer during the committee hearing conducted by the Committee on Budget, Finance and Appropriations, there is a need to augment the funding of the project for its entire completion and in order to serve its purpose, to provide clean and potable water supply to the residents of Barangay Paagan;

WHEREAS, this Body, upon the recommendation of the Committee on Budget, Finance and Appropriations in their Committee Report No. 2020-020, approves the realignment of funds from the following projects: a) Construction of Sagingsing Multi-purpose Bldg. - ₱1,000,000.00, b) Improvement of Various Foot Paths in Brgy. Ramot - ₱500,000.00 for the Completion of Paagan Water System amounting to ₱1,500,000.00;
