## **RESOLUTION NO. 2020-058**

RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING HON. WENDEL E. AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THRU POLICE GENERAL ARCHIE FRANCISCO F. GAMBOA, CHIEF, PHILIPPINE NATIONAL POLICE (PNP), TO KINDLY GRANT THE MUNICIPALITY OF SANTOL, ONE (1) UNIT 4x4 VEHICLE-PATROL TYPE WITH ACCESSORIES FOR USE BY THE SANTOL POLICE STATION.

**WHEREAS**, the existing two (2) PNP Patrol vehicles are already old and deteriorating posing risk and danger to the patrollers not to mention these were acquired way back 2009 and 2015, respectively,

**WHEREAS**, the Municipality of Santol is composed of six (6) mountainous barangays that are scattered and distant from one another causing difficulty on the part of the Philippine National Police (PNP) to conduct police patrol and address emergencies; hence needing an off road patrol vehicle in order to reach these barangays;

**WHEREAS**, due to the absence of an off road vehicle, PNP Personnel resorted to foot patrol in the upland barangays in order to sustain the peace and order in the municipality, safety and protection of the residents, making the populace to enjoy a sound sleep at night and alleviating the feeling of fear while traversing the long and winding roads thereat;

**WHEREAS**, said vehicle will not only utilize for patrolling but also of big help in the facilitation of rescue and search operations, transportation of victims, goods and services during and after calamities/disasters especially in the mountainous and far flung barangays of the municipality to which these operations must be supported by a 4x4 patrol vehicle;

**WHEREAS,** Santol is a 4<sup>th</sup> income class municipality dependently relying on its IRA and meager income, thus, we could not afford to acquire an expensive patrol vehicle that is primarily built to access harsh weather conditions and tough terrain; hence, we highly seek the help and assistance of the National Government;
