RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. MAGNO A. WAILAN, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTOL, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ILOCOS TRAINING AND REGIONAL MEDICAL CENTER REPRESENTED BY ITS MEDICAL CENTER CHIEF II, DR. EDUARDO M. BADUA III, FOR THE AVAILMENT OF THE SERVICES OF MOLECULAR LABORATORY TESTING FOR SUSPECT, PROBABLE AND CONFIRMED COVID-19 (SARS-COV-2) PATIENTS, THIS MUNICIPALITY.

WHEREAS, due to COVID pandemic, access to hospitals accredited by the Department of Health-Center for Health Development I as a COVID-19 (SARS-CoV-2) Testing Laboratory for emerging and re-emerging infectious diseases is significant to accommodate patient Santolians:

WHEREAS, ITRMC is the first hospital in Region I designated by the Department of Health-Center for Health Development I as a COVID-19 (SARS-CoV-2) Testing Laboratory for emerging and re-emerging infectious diseases not to mention it is the nearest hospital from Santol accommodating such cases;

WHEREAS, this joint undertaking is highly beneficial to the constituents of the municipality in this time of COVID-19 crisis;

WHEREAS, Section 444 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the Municipality in all its transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authorization of the Sangguniang Bayan or pursuant to law or ordinance;
