WAILAN, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTOL, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REPRESENTED BY ITS REGIONAL DIRECTOR, HON. NATHANIEL V. LACAMBRA, CESO III, ON THE IMPLEMENTATION OF THE LIVELIHOOD (KABUHAYAN) PROJECT ENTITLED FARM IMPLEMENTS PROJECT, THIS MUNICIPALITY.**

**WHEREAS**, this MOA will beneficial to the Tobacco Growers Association and Farmers Association in the municipality as this would unburden them of the costly tractor services during planting season;

**WHEREAS**, the Municipal Government pledges its support to this undertaking by providing the equity which equivalent to at least 20% of the project cost in the amount of Php250,000.00 for the supervision of the project or for other needs related to the project;

**WHEREAS**, for purposes of safekeeping and maintenance, the Municipal Government also provides lot space for the construction of the machinery's housing located at Barangay Corro-oy;

**WHEREAS**, Section 444 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the Municipality in all its transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authorization of the Sangguniang Bayan or pursuant to law or ordinance;
