RESOLUTION APPROVING THE REALIGNMENT/REPROGRAMMING OF THE SAVINGS FROM THE MUNICIPAL DEVELOPMENT FUND (MDF) AMOUNTING TO TWO HUNDRED FIFTY THOUSAND PESOS (Php250,000.00) FOR FINANCIAL ASSISTANCE TO SANTOL TOBACCO FARMERS' ASSOCIATION FOR THE PURCHASE OF THREE (3) UNITS HAND TRACTOR WITH TRAILER, AS RECOMMENDED BY THE MUNICIPAL DEVELOPMENT COUNCIL, THIS MUNICIPALITY.
