WAILAN TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTOL THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY ITS REGIONAL DIRECTOR, HON. MARCELO NICOMEDES J. CASTILLO, DSWD FO1, ON THE IMPLEMENTATION AND CONDUCT OF THE NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTS-PR), ALSO KNOWN AS LISTAHANAN, THIS MUNICIPALITY.

WHEREAS, submitted to the Sangguniang Bayan for consideration is the request of the Municipal Mayor for his authorization as stated above;

WHEREAS, the Philippine Constitution declares that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

WHEREAS, by virtue of Executive Order (EO) No 867 issued on March 9, 2010, the DSWD is mandated as the partner of the LGU in the implementation of the National Household Targeting System for Poverty Reduction (NHTS-PR), also known as the Listahanan, to establish a system for identifying who and where the poor households, update the data every four years, and share the data, especially to NGAs-which shall serve as basis in the selection of beneficiaries of social protection programs nationwide;

WHEREAS, the National Household Targeting System for Poverty Reduction (NHTS-PR), also known as the Listahanan, will be beneficial to the LGU to accurately and objectively identify poor and vulnerable beneficiaries of the poverty reduction programs to maximize efficiency and effectiveness of the government's resources;
