RESOLUTION DECLARING THE LOT UNDER TAX DECLARATION NO. 2018-16-0006-00004 LOCATED AT BARANGAY PAAGAN, THIS MUNICIPALITY SHALL BE EXCLUSIVELY USED FOR THE ESTABLISHMENT OF A MEMORIAL PARK-PUBLIC CEMETERY AND SANITARY LANDFILL OF SANTOL, LA UNION.

WHEREAS, the Deed of Absolute Sale involves the real property owned by Juan Orodio was purchased by the Municipal Government, more particularly described as follows:

"A parcel of land located at Barangay Paagan, Santol, La Union with an area of 62,749 square meters, under Tax Declaration No. 2018-16-0006-00004, designates as Cadastral Lot No.4149."

WHEREAS, the acquisition of the said real property shall immediately resolve the municipality's deficiency in providing decent and affordable burial sites for its constituency and to protect public health and ensure environmental sustainability by establishing a sanitary landfill that would cater the proper management and disposal of wastes;

WHEREAS, this Body hereby declares that said parcel of land will be exclusively used for the purposes stated above;

WHEREFORE, on motion of SBM William O. Agtarap duly seconded unanimously, be it;

RESOLVED AS IT IS HEREBY RESOLVED, to declare the lot under Tax Declaration No. 2018-16-0006-00004 located at Barangay Paagan, this municipality shall be exclusively used for the establishment of a Memorial Park-Public Cemetery and Sanitary Landfill of Santol, La Union.
