
WHEREAS, Article 410 of the Implementing Guidelines of R.A. 7160 provides that the Local Development Council shall submit to the Local Finance Committee a copy of the Local Development Plan and Annual Investment Plan prepared and approved during the fiscal year in accordance with applicable laws, specifying therein the projects proposed for inclusion in the local government budget;

WHEREAS, Article II, Section 15 of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consequences;

WHEREAS, by virtue of Republic Act (RA) No. 11494, otherwise known as the "Bayanihan to Recover as One Act of 2020" and the issuance of Local Budget Circular No. 128, Series of 2020 or the Guidelines on the Release and Utilization of the Local Government Support Fund-COVID-19 Financial Assistance to Local Government Units in the Bayanihan to Recover as One Act, R.A. No 11494 providing financial assistance to LGUs in their local anti-COVID efforts;

WHEREAS, in order to concur with the requirements/guidelines on the utilization of funds for COVID-19 heightened crisis, the Municipal Development Council convened last September 23, 2020 to discuss the possibility of making adjustments to the 2020 AIP;




THE SANGGUNIANG BAYAN OF SANTOL, LA UNION IN SESSION DULY ASSEMBLED:
