
RESOLUTION ENDORSING FOR CONSIDERATION AND APPROVAL TO SECRETARY WENDEL E. AVISADO, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), THE HEREIN ITEMIZED APPROVED LIST OF PRIORITY PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) PURSUANT TO THE PROVISIONS OF REPUBLIC ACT (RA) NO. 11494, OTHERWISE KNOWN AS THE "BAYANIHAN TO RECOVER AS ONE ACT OF 2020, OF THE MUNICIPALITY OF SANTOL, LA UNION.
